

### BIOLOGICAL ACTIVITY OR INHIBITORS

Alliin, one of the active principles of freshly crushed garlic homogenates, has a variety of antimicrobial activities, including antibacterial, antifungal, antiviral, and, antiparasitic activities; the main antimicrobial effect of alliin is due to its chemical reaction with thiol groups of various enzymes, e.g. alcohol dehydrogenase, thioredoxin reductase, and RNA polymerase, which can affect essential metabolism of cysteine proteinase activity involved in the virulence of *E. histolytica*. Alliin has antiproliferative effects, it can inhibit the growth of cancer cells of murine and human origin, induce the formation of apoptotic bodies, nuclear condensation and a typical DNA ladder in cancer cells. [2]

Alliin from garlic powder is beneficial in reducing blood cholesterol, triglycerides levels and systolic blood pressure in hypercholesterolemic rats, it may beneficially affect two risk [3]

Alliin exhibits antioxidant activities as protective compounds against free radical damage [4]

Alliin can strongly inhibit cysteine proteinases and cytopathic effects of *Entamoeba histolytica*. [5]

Alliin is an anti-inflammatory agent, it exerts an inhibitory immunomodulatory effect on intestinal epithelial cells and suggest that alliin may have the potential to attenuate intestinal inflammation. [6]

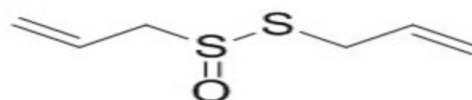
