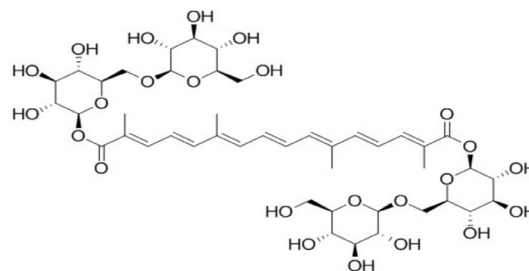

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Crocine is a pharmacologically active component of *Crocus sativus* L. (saffron) used in traditional Chinese medicine, crocin is a unique and potent antioxidant that combats oxidative stress in neurons. [1]

Crocine has water-solubility and high inhibitory growth effect, cells treated with crocin exhibit wide cytoplasmic vacuole-like areas, reduce cytoplasm, cell shrinkage and pyknotic nuclei, suggesting apoptosis induction; so crocin is the more promising saffron compound to be assayed as a cancer therapeutic agent. [2]

Saffron extracts have antitumor effects, radical scavenger properties or hypolipemic effects, saffron extract or its active constituents, crocetin and crocin, could be useful [3]

Crocine and crocetin have anti-inflammatory effects, provide neuroprotection by reducing the production of various neurotoxic molecules from activated microglia. [4]

Crocine yields its hypolipemic effect by inhibiting pancreatic lipase, leading to the malabsorption of fat and cholesterol. [5]

Crocine protects the photoreceptors against blue light- or white light-mediated damage in a concentration-dependent manner with an EC<sub>50</sub> of approximately 30 μM, crocin protects retinal photoreceptors against light-induced cell death. [5]

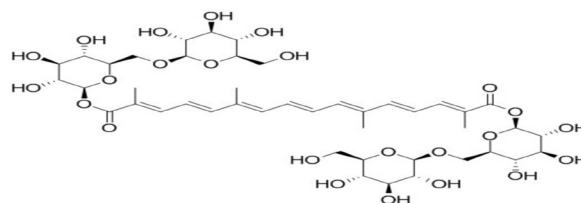
